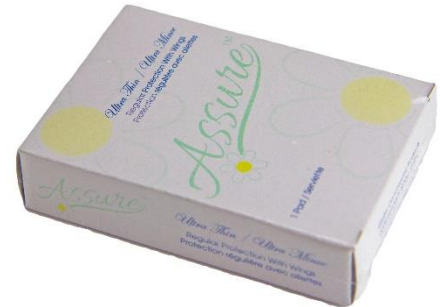

Installation Guidelines: To install in a Frost vending machine, use the two keys provided and open the door. Remove the steel weight from the napkin holding side. Slide the napkin boxes into the slot and place the weight back on top. Then close and lock the door.

Maintenance: Normal preventative maintenance and cleaning will keep Frost products functioning properly and may extend normal product life. Products should be wiped down with a damp soft cloth periodically. Approved stainless steel cleaner may be used to clean scuffs or fingerprints on stainless surfaces. Do not use harsh detergents or chemical cleaners. For general dirt and blemishes on painted steel or plastic use warm water and mild soap, or a general mild cleaning solution. When using any type of cleaning solution, spray onto a discrete area to test before full usage. After the cleaning agent is applied, wipe off with a clean soft cloth or sponge.

Warranty: If any product or part proves to be defective within 12 months from date of shipment from the factory it will be repaired or replaced without any charge including freight costs when authorized. Costs resulting from the installation or removal of defective products are not covered under this warranty. Discolouration to stainless steel parts resulting from exposure to harsh environmental and / or chemicals are not considered to be defects in workmanship or material and are not covered under warranty.
